BY-ELECTION FOR KITUTU CHACHE SOUTH CONSTITUENCY
SCHEDULED TO BE HELD ON 7TH NOVEMBER, 2017

IN EXERCISE of powers conferred by Articles 88 (4), 97 (1) (a), 99, 101 of the Constitution of Kenya, sections 2,13 (3), 16, 20, 24, 26, 30, 31, 38, 39, 49 and 74 of the Elections Act, 2011 and Regulation 11(4), 12(1) 14 and 15, Parts III,V and VIII of the Election (General) Regulations, 2012 the Independent Electoral and Boundaries Commission gives notice that:

- (a) Pursuant to Gazette Notice No. 7621 of 2017 published on 7th August, 2017 there shall be a by-election for Member of National Assembly for Kitutu Chache South Constituency on 7th November, 2017.
- (b) Political Parties whose candidates passed on are required to submit the details of their candidates to the Commission on or before Tuesday, 5th September, 2017
- (c) The days for the nomination of Political parties whose candidates passed on are required to submit the names of their proposed candidates on Thursday, 7th September, 2017 and Friday, 8th September, 2017 and nomination papers shall be delivered by candidates to the respective Returning Officers between the hours of eight o'clock in the morning and one o'clock in the afternoon and between the hours of two o'clock and four o'clock in the afternoon at the place designated by the Commission.
- (d) All candidates who had been cleared to participate in this election prior to the 8th August, 2017 General Election, to verify their details and documents with the respective returning officer on the nomination days.

- (e) Disputes relating to or arising from nominations shall be determined within ten (10) days of the lodging of the dispute with the Commission.
- (f) The campaign period for purposes of the 7th November, 2017 by-election shall commence on, Thursday, 7th September, 2017 and cease on 5th November, 2017 being 48 hours before the by-election Day.
- (g) The Campaign time shall run from 7.00 a.m. to 6.00 p.m. during the campaign period.
- (h) Political parties and Independent candidates shall appoint and submit to the Commission the names of their Chief Elections Agents to the Commission on or before 23rd October, 2017.
- (i) The registration and revision of the register of voters for the said constituency is suspended until 8th November, 2017
- (j) If the elections are contested, the poll will take place on the 7th November, 2017.

1. The attention of candidates and persons subscribing nomination papers is drawn to the provisions of Parts III, V and IX of the Election (General) Regulations, section 13(2) and the First Schedule to the Leadership and Integrity Act No. 19 of 2012 and Chapter Six of the Constitution of Kenya.

- (g) A dully filled nomination form
- (h) A certified copy of the National ID/Passport
- (i) Certified copies of Academic certificates
